#### **Topic 5: Organisation incl. formal status**

At the moment, the EUCALAND Network is an informal network, open to individuals and organisations. The topic of whether to formalise the Network is complex, thus the members asked for an **email voting**. We present briefly the discussion points of formalisation and then four options with explanations from which you should choose.

#### Pros:

- 1. The Network as an entity could submit project proposals.
- 2. The Network would have more possibilities to join to international discussions and organisations making our expert voice more heard.
- 3. The Network could start looking into publishing and branding itself.
- 4. The administration of the Network would be easier (upkeep of web page etc.).

#### Cons:

- 1. If the Network becomes a formal association, it represents ONE organisation and not many different countries anymore (counterproductive for the original aim).
- 2. A formal body risks managing itself, but not the aims of the network any longer.
- 3. Loose network enhances better personal contacts and ideas, people are not forced to work together.
- 4. Dependent on where the formalisation takes place different requirements are needed to meet, e.g. statutes, first meeting, formal board elections, ability to give electronic signature, bank account with some beginning capital, administration costs like hiring a accountant etc.

#### Option 1: Remain as an informal open Network (like PECSRL)

#### **Positive**

- Conserving status quo: democratic, interdisciplinary, open network
- Networking and cooperation with all associations and individuals possible
- Easy to facilitate because there are no formal requirements
- Easy access for people and organisations who are interested
- It represents a large number of different countries
- Easy to take over tasks or responsibility

#### **Negative**

- Difficult to get funds and financial support because of a missing legal body
- Difficult to facilitate because of a lack of formal structures
- No formal board and professional administration in order to serve and assist the members requirements
- Difficult to find members who take over tasks or responsibility

### Option 2: Formalisation as a German<sup>1</sup> (or other) association (e.V.)

#### **Positive**

- The Network will receive a formal status and therefore will be equal to other European organisations but also "equal" to universities etc. when applying for European funds
- The Association will be able to apply for European funds
- A formal structure requires and facilitates to share tasks and responsibility
- Independent organisation
- Demanded by the members in 2008 (Óbidos)
- To fulfil the Networks aims and tasks is possible

#### **Negative**

- The Association will be registered in one country and therefore is not representing several as an organisation any longer
- More, higher administrative tasks/requirements (accountancy, tax declaration etc.)
   means more work load
- Member fee is needed in order to facilitate the administration if applying for funds does not succeed

#### **Background**

**CIVILSCAPE - a European network NGO for the European Landscape Convention** 

- CIVILSCAPE is an international association of civil society organizations. These are non-governmental organisations (NGO) which dedicate their work to landscape protection, management and planning, according to the "European Landscape Convention" (Florence, October 20th 2000).
  CIVILSCAPE is dedicated to creating an enabling environment for civil society organizations, documenting the civil society organizations community, strengthening the infrastructure of the citizen sector, and promoting collaboration, both among civil society organizations and between civil society organizations, political or administrative bodies and other actors, to advance the public good in Europe and
- CIVILSCAPE has registered as a lobby organization with the EU.
- CIVILSCAPE cooperates with two partners on European level. Both European partners are umbrella organisations like CIVILSCAPE:
  - RECEP-ENELC is an international association of local and regional authorities promoting the implementation of the European Landscape Convention continentwide. It was established in 2006, under the aegis of the Council of Europe's Congress of Local and Regional Authorities.
  - 2. UNISCAPE intends to support and reinforce scientific interdisciplinary cooperation among European universities regarding landscape issues, notably in the areas of research and teaching.
- CIVILSCAPE has several legal entities, among other: CIVILSCAPE Competence Center UG

EUCALAND Network is already (founding) member of CIVILSCAPE

#### **Implementation**

- Founding a European Center for Agricultural Landscapes as coordination office for the ongoing activities (network secretary, organising EUCALAND workshops, meetings and projects) By the end of the year as a daughter of CIVILSCAPE Competence Center UG.
- Starting as a virtual office, the Center shall be established with external funding during the next two years.
- The EUCALAND Network (Center) will act as a scientific council of CIVILSCAPE
- Members of the steering committee will be elected by the network members

- One EUCALAND board member shall have a seat in the CIVILSCAPE board.
- EUCALAND Network members can additional become CIVLSCAPE members (not a must)

#### **Positive**

- Will remain as a network open to personal and institutional members
- Will have its own EUCALAND website supported by CIVILSCAPE (web space, Content management system etc)
- Will have a EUCALAND annual report published online and with printed copies
- The Center remains independent in scientific content, aims, projects
- EUCALAND can initiate and participate to European projects using
- CIVILSCAPE (Dutch association) and/or
- CIVILSCAPE Competence Center UG (German ltd recognised as a charity, CIVILSCAPE owns this company) as a proxy
- Both bodies are established with a formal infrastructure (fundraising, public relation and formal relations towards CoE and EU) that can be used for further network activities
- "Bigger" and better administration infrastructure; => less work for the network members

#### **Negative**

The Network will be a subgroup of another organisation

# Option 4: Founding of a German association<sup>2</sup> with only the aim of fundraising of finances in order to support the EUCALAND Network

#### **Background**

- This option was brought in during the discussion.
- A minimum of 7 persons (members) is required in order to fund a German association. Therefore the idea was brought up to fund this kind of association as a core association with only two aims:1. fundraising of finances in order to support the EUCALAND Network and 2. to maintain its administration.

#### **Positive**

- The Network remains with its informal and open character
- The Network keeps its international character, representing a large number of countries

#### **Negative**

- This association needs also some funds for themselves in order to finance its administration. The formal requirements (accountancy, tax declaration etc.) remains the same, no matter, how many member the association has.
- It means a lot of work and responsibility for the members of this small association as it is on them, to keep the Network running.
- You need to find volunteers for that task.
