- SE, ZK, CC and AK accepted all abstracts, informed all authors about our decisions and provided the evaluators' comments. Some of them replied friendly and accepted.
- We have recommended to re-direct the 2 abstracts for the "Historic garden & landscape" session in cooperation with Lionella) to other sessions. The conference organisers have promised to inform the session chairs in question.
- None of us has yet registered to the conference nor booked a flight. Due to the Covid19-situation and related travel restrictions, the situation is too uncertain.
- For information: By 4th of April, The local organisers had received approx. 100 abstracts.
- For information: AK has asked to mention EUCALAND's GA in the official program, to provide a room on Monday evening and to schedule the EUCALAND special session 15 either on Monday afternoon or (preferred) Tuesday morning.
